NOTIFICATION

In exercise of the power conferred by Section 112 of the Factories Act, 1948 (Central Act No. 63 of 1948), the Governor of Tripura hereby makes the following rule further to amend the Tripura Factories Rules, 2007, namely:-

- i) These Rules may be called the 'Tripura Factories(Fourth Amendment) Rules. 2016':
 - They shall come into force with effect from the date of its publication in the official gazette;
- In sub rule 5(a) of Rule 9 of the Tripura Factories Rules, 2007 (hereinafter be referred as the "Principal Polics), he words "3(three) years" shall be substituted by the words "10(ten) years".
