NOTIFICATION

Business Reform Action Plan, 2023 formulated by the Department for Promotion of Industry & Internal Trade (DPIIT); Government of India under Ease of Doing Business requires publishing an online Dashboard in public domain for Joint inspection conducted by the Factories & Boilers Organisation, Labour Directorate, Tripura State Pollution Control Board and Legal Metrology for factories/establishments registered under various laws.

The Factories & Boilers Organisation mandates to publish the data related to inspections in an online Dashboard in public domain with following features:

- i) The data on number of inspections conducted, number of Inspections Completed and the maximum time taken and cost incurred to complete the inspection.
- ii) The dashboard is updated on real time basis.

The dashboard will show the following data: -

- 1) Total Number of Inspections Conducted.
- 2) Total Number of Inspections Completed.
- 3) Average time taken for Conducting Inspections.
- 4) Median time taken for Conducting Inspections.
- 5) Minimum time taken for Conducting Inspections.
- 6) Maximum time taken for Conducting Inspections.
- 7) Time Limit prescribed as per the Tripura Guaranteed Services to Citizens Act, 2020
- 8) "Average fee" taken by the Department for completion of entire process of inspection.
- 9) Total Number of companies that provided self-certifications and were exempted from inspections.
- 10) Total Number of companies that provided third party certifications and were exempted from inspections.
