- 1) Submission of online application, payment, tracking & monitoring, verification for approval of plan drawing, registration & grant of licence for Factory and renewal of Factory/Boiler operation licence,
- 2) Provision of download the final signed approval certificates for Factory/Boiler from the online portal,
- 3) Provision to easily verify the approval certificates by third parties for Factory/Boiler in the public domain of at least two years,
- 4) Clear Timelines for approval of plan drawing, registration & grant of licence for Factory/Boiler and renewal,
- 5) Inspection Procedures under the Factories Act., 1948,
- 6) Submission of Inspection report within 24 hours,
- 7) Provision to view and download the submitted Inspection report by the users,
- 8) Same Inspector will not Inspect the same establishment registered under the Factories Act. twice consecutively.

This system ensures that there will be no physical touch point for the activities such as application submission, payment, tracking and monitoring etc. The user will be able to download the final signed approval certificate from the online portal through his user login. Procedures, comprehensive list of documents required, clear timelines and third party verification of all above said services are also available in the above said website.
