NOTIFICATION

In exercise of the powers conferred under sub-section (3) of Section 34 of the Boilers Act, 1923, the Government of Tripura in Factories & Boilers Organisation (Labour Department) hereby notify the risk assessment for delivery of services to the citizens/ entrepreneurs and online submission of inspection report under the Boilers Act, 1923, Indian Boiler Regulations, 1950 and Rules made thereunder.

Risk Categorization

Computerised systems of risk assessment based inspections with random allocation of Inspecting Officials, the risk classifications of Boilers are as under:

Category	Types of Boilers	Inspection requirements	Inspection Frequency
High Risk	All other types of fired & unfired Boilers	Hydraulic Test and through examination.	1 Year
Medium Risk	Small Industrial Boilers (other than coil type or once through Boilers)	Through examination. In case of HMT type Boilers, Hydraulic Test & through examination.	1 Year
Low Risk	Coil type or once through Boilers	Hydraulic Test	1 Year

- 1) Selection of establishments for inspection will be determined using computerised risk assessment. The Boilers will be selected randomly as per the frequency of inspections indicated above. The Inspecting Officer will be selected randomly through computerised online inspection module and same Inspecting Officer will not inspect the same establishment twice consecutively, if more than one Inspecting Officer is available in the Department.
- 2) The Inspection Report will be uploaded online in the Central Inspection System (CIS) by the Inspecting Officer within 48 hours. An alert will be sent to the Owner prior and post inspection to view/download the inspection reports of at least past three years.
- 3) Surprise inspection or inspections based on complaints, to be ensured that details are recorded in the system.
- 4) Inspections shall be limited to the checklist except complain-based inspections.
