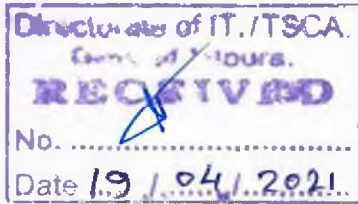
**OFFICE MEMORANDUM**

**WHEREAS**, there is a need for simplification of procedures for hassle free statutory clearances for rapid industrialization and recommended by the Department for Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry, Government of India for introduction of online registration facility for registration of Boilers and registration of Boilers Manufacturer and to mandate that the same inspector will not inspect the same establishment twice consecutively.

**NOW, THEREFORE**, according to the guidelines communicated by the DPIIT, Government of India and considering the prevailing situation of the State, provision of online facility for submission of application for registration of Boilers, registration of Boiler Manufacturer and the same inspector will not inspect the same establishment twice consecutively under the Boilers Act, 1923, the Boiler Regulations, 1950 and Rules made there under are **Not Applicable ( N/A)** at this stage in the State of Tripura, as –

- 1) Online registration of Boilers and registration of Boilers Manufacturer is not in practice in the State of Tripura due to applications are less than 20 (Twenty) in a year as the State, Tripura is situated in such a place in N.E. Region where no suitable transportation system is there with the mainland of the country.
- 2) Same inspector will not inspect the same establishment twice consecutively as there is no Inspector of Boilers in the State, except Chief Inspector of Factories & Boilers.

This Office Memorandum is issued in cancellation of earlier Office Memorandum No. F. 2 (345)-FB/EoDB (SRAP)/2020/1404-12 dated 16.10.2020 and shall have immediate effect.
