NOTIFICATION

WHEREAS, under "Business Reform Action Plan, 2016", there is a need for joint inspections for factories/establishments registered under various labour laws ;

AND WHEREAS, there is a scope of joint inspections for suitable settlement of various disputes;

NOW, THEREFORE, the Governor of Tripura is pleased to constitute the following 'Joint Inspection Teams' under Labour Department, Govt. of Tripura to conduct inspections jointly for suitable settlement of disputes under the provisions of different Labour Laws, like Equal Remuneration Act, 1976, Factories Act, 1948, Maternity Benefit Act, 1961, Minimum Wages Act, 1948, Shops and Establishments Act, Labour Welfare Fund Act, Payment of Bonus Act, 1965, Payment of Wages Act, 1936, Payment of Gratuity Act, 1972, Contract Labour (Regulation and Abolition) Act, 1970 etc. now in force in the State under the concept of "Business Reform Action Plan, 2016". Joint inspections are to be conducted, as and when necessary, to address the specific issues like investigation into any complaint, investigation of accidents / dangerous occurrences etc.




This shall come into force on and from the date of its publication in the Official Gazette.
